## I. Background

Community Participation & Development (CPD) has been working since 1993 which was initiated by a group of local enthusiastic social workers with a view of uplift the social and economic conditions of distressed women, Children and youth of different areas of Bangladesh. It has been implementing programs with the disadvantaged people, like childcare, health, women empowerment, adolescent development, skill development training, vocational skills training, apprenticeship and job placement for the graduated children through CSR, basic education, pre-schooling, Non Formal Education (NFE), soft skill/life skill/Employability and income generation activities, Sexual and Reproductive Health (SRH), Health services, climate change and adaptation, disaster risk reduction, Anti trafficking, anti-terrorism, child abuse and harassment by the support of national and international donor. All these components enable destitute and disadvantaged target children, youth and women to change their socio-economic condition and consequently the project will act as a supplementary program of the national plan. The basic objective is to uplift the socio-economic conditions of the disadvantaged women, children and youth. CPD believes that to improve the living condition of the disadvantaged women and adolescents and promote self- reliance is the key to meet the long-term needs to the beneficiaries struggling to overcome poverty and social insecurity. CPD also started working with the youth to create options of livelihood for them within the project areas in line with Education Prevention, Livelihood and protection. CPD is working to change in policies and practices affecting children's and young people's rights.

The organization is striving to make itself institutionally, program wise and financially sustainable without compromising the quality of services.

#### **Vision**

Empowerment of disadvantaged community, particularly women, adolescents and children under urban & rural areas in Bangladesh through increasing their living capacity for poverty reduction and social security towards good governance.

#### **Mission Statement**

CPD has been working both in rural and urban areas in Bangladesh for development of livelihood of the disadvantaged women, children and youth. CPD has been working with the target groups in an integrated approach through implementing different activities, such as, child education, vocational education, health services, social awareness, income generating activities, skills development training, advocacy program, child club activities, employment generation, combating trafficking, disaster risk reduction and climate change adaptation etc.

CPD adopts different strategies, such as, mobilization of skilled staff members, involvement of stakeholders and empowerment in implementation of its programs. Besides that, CPD co-ordinates with local government and local administration for developing livelihoods of disadvantaged children and women.

CPD believes and practices honesty, neutrality, transparency, accountability in implementation of different needs based program.

- To ensure community involvement towards program sustainability.



## 2. Overall experience of CPD

#### **Anti-Trafficking**

With the support of terre des hommes (Tdh Nederland's), CPD worked in the project of "Prevention of Child Trafficking through Strengthening Community and Networking" since March 2015 to 31st December 2020 at Dhaka, Borguna, Patuakhali, Barisal and Bhola. Under this project CPD implemented sensitization meeting with Parliamentary Standing Committee and Caucus on Child Rights at national level to include child trafficking issues, Press conference for better implementation of laws, policies, NPA related to Child Trafficking at National, District and Sub-District level, Meeting with Counter Trafficking Committee on Child Protection issue at National, District and Sub-District level, Meetings with teachers / SMC/ community leaders/ religious leaders/ Kazi/elected bodies at District and Upazila level on Child Protection issue, Orientation meeting with relevant govt. officials and CSOs on new NPA on Human Trafficking and monitoring the reporting system at District and Upazila level.

CPD conducted a vast number of School campaign in Dhaka along with the field level where CPD also appointed child ambassadors in several schools to strengthen the project objectives. CPD build a close relation to different ministry of MoHA, MoWCA, MoSW and Member of Parliamentary Standing Committee, Human Rights Commission, National Legal Aid Services Organization during the Prevention of Child Trafficking through Strengthening Community and Networking project.

With the financial assistance of Children at Risk Netherland, CPD worked in the project of "Campaign Against Child Trafficking" from January 2002 to December 2006 at Mohammadpur of Dhaka district, Chandrapur, Daikhawa, Mogilghat of Thakurgoan and Lalmonirhat district and Haripur and Khanpur

in Dinajpur district. This project conducted awareness raising workshop, parents/guardian meeting, school campaign, boarder campaign, mobile campaign, motivation and counselling of the parents/guardians and community for reintegration of the victims, advocacy and social mobilization workshop, rally, use of IEC materials. Through these activities, at the end of the project, the community people, law enforcing agencies and local elected bodies strengthened within their catchments areas to prevent child trafficking.

#### **Anti-terrorism**

From 2019 to now CPD implementing MotherSchools project with the support of Women without Border through Manusher Jonno Foundation. Under this project 725 mothers will be completed the parenting for peace model and they committed to safe guarding the next generation from violent extremism and they are equipped and ready to build a new bottom-up security architecture, instilling resilience in their children, families and communities. These graduates will the tools to be a driving force of urgent change that starts in the hands of civil society.

## Climate Change Adaptation (CCA)

From January 2012 to August 2021, CPD worked the project on "Climate Change Adaption (CCA)" and which is funded by Save the Children and AUS-Aid.

CPD is working with a burning issue climate change adaptation and disaster. Integrated Child Centered Climate Change Adaptation project has been organized by Save the Children International with financial support from AusAID. There are total 1500 beneficiaries, 1200 caregivers in which 10 schools have been included. The working area of this project is Ward no 29-33, Mohammadpur, Dhaka. Projected children, caregivers, stakeholders, ward member are involved in the training on CCA, CVCA, TFD/Street drama, Workshop, meeting, special day observation, IEC materials development (Flip chart, festoon, Sticker, Session guide, CVCA guide etc.) and video documentation.

Under this project the main activities were sessions conducted with children, youth, Community people on CCA and eco-friendly life living, meeting conducted with green club members & School children at school on CCA, Day observations (International Day for Disaster Risk, National Disaster Preparedness Day, World Environment Day etc. and arrangement a mock drills at school level, trainings are organized with children with disabilities (CWD), people with disability (PWD), youth and caregivers on child rights, child participation, CCA and resilience and national dialogue on climate finance and children.

To enhance the community resilience children's have been assessed Climate vulnerability capacity in their respective area. They have identified the problem in their respective area and make an action plan. They are applying few techniques of adaptation such as using jute made products, avoid plastic materials, small yard gardening, roof top gardening, using separate waste box for degradable & non-degradable product. Children's have also made 6 climate resilient child clubs in their area. Child club is the center of knowledge for the children, they become sensitize on CCA. Each club has 20 volunteer children to implement adaptation technique as per action plan. Now the children are working in their communities, school, ward level & also attending national level program by increasing their capacity to act as champions for adaptation.

### **Disaster Risk Reduction (DRR)**

From June 2016 to October 2021CPD implemented Strengthening Urban Resilience Project funded by European Civil Protection and Humanitarian Aid Operations (ECHO) and Technical supported by Save the Children International at Word No 29, 30, 32 & 34 of Dhaka North City Corporation and 10, 14, 15 & 16 ward of Narayanganj City Corporation. Under the project CPD arranged capacity development training for WDMC, UCVs, city corporation zone office and utilities staffs for a resource pool to operationalize ward level contingency plan and URA, Facilitate WDMC to develop and implement ward level participatory and inclusive contingency plan and Urban Risk Assessment, Arrange basic training for the new urban volunteers (UCVs) and refreshers for the existing urban volunteers by FSCD, strengthen capacity of hospitals authorities on hospital contingency and mass

casualty management plan, support schools to apply school safety plan and SOPs for simulation exercises in 16 schools.

CPD Integrated and mainstream DRR in organization level. CPD has executed series of activities in a very systematic manner in some sequential steps. Which are a. Decision making by the management of organization; b. Conducted workshop for the staff of CPD by the consultant of SCI to prepare the organizational DRR integration plan; c. Capacity building of staff of CPD; d. Implementation of project wise DRR integration plan. Towards mainstreaming DRR at other projects CPD organized awareness raising and capacity building initiatives for the stakeholders of other projects, organized campaign, TFD etc. Child to Child approach is used for training and awareness rising of working children, NFE students and Community children under other projects.

## **Emergency Response on COVID 19**

Unconditional Cash Support of SURP-II project supported by ECHO and the Hygiene and Behavior Change Coalition (HBCC) project, funded by Unilever, CPD provided BDT. 4500 by using Mobile Money Transfer (MMT) to 600 beneficiaries at Mohammadpur, Dhaka and 814 beneficiaries of 15 and 16 ward of Narayanganj City Corporation from June 2020 to December 2020.

Under the HBCC project, CPD prepared 30 hand washing station at educational institutions, public health facilities, government stakeholder premises, DC offices, UNO Office, Fire Service and Civil Defense, Public health facilities, Schools, Clinics and Hospitals and Religious Institutions and CPD distributed health and hygiene materials within 25032 beneficiaries at Dhaka and Narayanganj . Different types of IEC materials such as 1500 leaflets, 1000 posters, 2000 stickers, 4 display boards and 5 festoons were disseminated across the community. These materials were developed on different messages including good hygiene practices, social stigma, handwashing steps, social distancing, quarantine, etc.

Field hospital equipment's provided to General Hospital (Victoria), Narayanganj under CPD's SURP-II Project to increase capacity and continue medical facilities in emergencies especially COVID-19 by the support of Save the Children and the European Civil Protection and Humanitarian Aid Operations (ECHO)

Urban Community Volunteers of CPD distributed & miking on general awareness on COVID-19 including promotion of government instructions and relief distribution on behalf of respective Ward Disaster Management Committee (WDMC)/ Ward Councilor. Urban community volunteers (UCV) of CPD has been spraying anti-germ liquid on regular basis in working area.

Department of Social welfare and CPD jointly provided food support to 300 vulnerable households.

Supported by FCDO through CPDRSS project, CPD distributed dry food, cleaning and hygiene materials and developed IEC materials for working children.

#### **Skill Development Training**

CPD has 24 years' extensive experience providing skills development Training (TVET) to the disadvantaged children and youth like dropout from education, living under the poverty line, related with hazardous labour. A total 6500 (Approximate) children has got the Trade specific skill training from the Vocational Training Centre of CPD and 4354 children and youth have been offered age appropriate decent job. Quality vocational training is a central prerequisite for giving children and youth access to decent job opportunities. CPD has established an upgrade VTC with modern equipment, Professional Instructors and competencies based comprehensive curriculum that helps students to stand in competitive job market. CPD provides skills training on I. ICT (Graphics design, Web Design, Finance and accounting and Customer care) 2. Basic Computer Knowledge, 3. Industrial Sewing Machine Operation & Tailoring, 4. Industrial Garments Machine Maintenance, 5. Garments Finishing and Quality Control, 6. Electrical House Wiring and Solar System 7. Electronics and Mobile Phone Servicing 8. Beauty Care 9. Petrol & Diesel Engine Mechanic 10. Housekeeping. The graduates are received certificate as proof of their training. Official recognition is important to raise the status of vocational training to make workers possessing this certification more attractive to

employers. CPD maintain occupational health and safety precaution measures in the VTC. In addition, CPD provide soft skills training like: OHS, Fire Drilling, Vision exercise, employability training.

## NFE for Child Laborers and Urban Slum Children

From 1993 to 2022 CPD is one of the well-known organization in providing Non-formal Basic education for the working and out of school children in urban areas of Bangladesh. It has working for last 20 years in the field of basic Education in combination with technical & vocational training funded by different donors like World Bank through Directorate of Primary Education (DPE), Danida through Save the Children, FCDO/DFID through Manusher Jonno Foundation (MJF), UNICEF, ICCO-KIA, as well as corporate like IKEA foundation & Lafarge. With this long experience CPD provided education support to 17353 children & Youth in 15 wards under Dhaka City Corporation and 5 Districts of Bangladesh. CPD is working with 72 formal schools in different areas of Dhaka city Corporation and all over the country where NFE students are mainstreamed.

Under the Urban Slum Children Education Program (USCEP) of ROSC II project CPD worked with 43 learning center at Dhaka North City Corporation, Dhaka South City Corporation and Sylhet. Total 4853 dropout children enrolled in NFE. They completed Primary Education Certificate (PEC) under USCEP, ROSC II Project.

Under the Education for Youth Empowerment (EYE) Program Phase II of Danida Frame program of Save the Children, CPD has 23 Non Formal Education Center in different areas of Dhaka City Corporation for the hazardous children. In the NFE school 4500 children got education from grade I to grade VIII. NFE is put in place with the key objective of providing education for working children and the children who are at risk to be labour and who live at urban slum area as an alternative to the formal education stream. It was a comprehensive education model for getting working children and vulnerable youth into education or decent employment, enabling them to influence decisions that affect their lives and advocate for their rights.

With the support of FCDO through Manusher Jonno Foundation CPD is implementing a project where 8000 hazardous working children receiving education from multiple centre to get enrolled themselves into formal schools. Withdrawn working children and children at risk to be labour are enrolled in NFE program in two shifts. The children whose age is over to admit the formal school, they receive nonformal education through child club approach of CPD. So it helps to the older children to be involved in education.

#### Health

CPD implemented the project titled "PAP Development Project" funded by LAFARGE from 2002 to 2012 and "Adolescent Reproductive Health Project" funded by USAID/BCCP from 2008 to 2011 and "SUCHONA Project" funded by Save the Children from 2016-2017 at Dhaka and Sylhet.

It has adopted a two prong service delivery approach by incorporating out door and satellite clinic and community based interventions to bring positive changes in behavior and attitude of the beneficiaries. The project aims to ensure health and reproductive health services for underprivileged and marginalized women and children, youth and adolescent girls ensuring accessibility of the poor and hard to reach population focusing on general health care, malnourished care, scabies treatment, vaccination, family planning, Sexual and Reproductive Health and Rights (SRHR). CPD provided Schools based adolescent SRHR education programs continued in all project areas at enlisted schools. These sessions have helped the school adolescents to develop a positive attitude towards SRHR stamping out the negatively gendered views, and have been able to create a demand to learn more through continuation of the sessions. School dropout adolescents were covered through BCC sessions on adolescent SRHR issues. Adolescents are awarded on different topics of SRHR and show their determination to learn more so as to understand the effects of early marriage, early pregnancy, unsafe childbirth, maternal health problems and other SRHR issues that concern them.

## Early childhood care and development (ECCD)

CPD has the experience of running the day care centre including pre-schooling for 800 children from 1996 to 2002 in Child Care Program under UNWA. When the mothers are at work, the little children

are left uncared at home. So CPD started this program to take care of the siblings and stop children who are at risk to be labour. Pre-schooling was provided to these children and after that they got admitted in CPD's NFE School or mainstreamed in formal school. This program helped the children from involving into the labour market. Under the EYE program child clubs in different areas 200 children get ECCD supports. Child club facilitator tells stories to children and children also get story books in the Child club.

## Adolescent Development Program (girls)

Adolescent Development Project (ADP) of CPD has been working for disadvantage adolescent girls in Mohammadpur area for last 12 years under ICCO-KIA, the Netherlands. The working areas are Bashbari, Nobodoy, PC Culture Housing, Adabor of Mohammadpur of Dhaka city Corporation. The basic aim is Girl Child laborers access safe livelihood and development options in an enabling environment.

CPD has been running Iyear-NFE program During the NFE course skill training starts and continues for six months. The Education for Adolescent is compulsory for all the children. After completing the education course, interested ones go for mainstreaming and the rest go for self-employment or some income generating process after receiving the skill training on need based trades. Most of the girls got admitted in formal school and in the afternoon school. Some of the children got admitted in formal school in the morning shift.

## **Vocational training and Corporate Social Responsibility (CSR)**

Children and young people who have completed grades 5-8 or the equivalent are eligible to enroll in a 6-9 month vocational skills training course from the "EBEA", "CAUSE", "ELWCAW", "VTVC", "IT Exploration Project", and "EUCSR" project. The training course consists of an apprenticeship within the respective industry, through which children can learn about the industry environment and gain the skill needed to work in the industry. Training courses provide technical skills for specific trades such as electronics, industrial sewing and apparel, and screen-printing. Each training course is operated by an industry professional with a child-friendly, and engaging, hands-on approach.

CSR is an efficient tool to persuade corporations to participate and contribute to the child rights agenda by combating the most harmful child labor practices. By supporting vocational training and learning about existing labor laws, employers and corporations move away from harmful child labor to providing safe and decent work. Employers in the formal sector increase their competitive advantage by gaining access to skilled labor through apprenticeships and job placements.

#### Micro credit

As the parents sometimes are not interested and force their children to earn money instead of mainstreaming them, CPD has introduced credit program for their parents. Parents, specially the mothers are involved different income generating work. This incentive created a very good impact in sending children to the school. The older children also have the access in micro credit after completion of market relevant vocational training. So these children go for self-employment.

## Women empowerment

With the support of Kringloop Netherlands, CPD work in the project of "Women Development Program" since 1998. The tradition and cultural norms in the society confer a lower status on women as compared to men. Gender inequality is established through socio-economic inequality and unequal distribution of and authority as well as resources. All these naturally influencing women to grownup and live with a lower self-image and a tendency to be submissive to exploitative behavior. Exploitation is to its highest level when a woman is illiterate, unskilled and dependent on man. Her suffering increases when she is pregnant and when she has frequent child births. CPD has been engaged in various activities to help them to participate in the economically productive role, to raise the awareness and knowledge level (about social, health and family planning) of women and adult to strengthen their position in the society. This would make them aware to change their attitude about child rights issue, about providing education to both women and adolescents. To enhance the potentiality and capability for improvement in their lives of women and create self- employment

income generating scope by providing credit facilities and different skill training are the objectives of CPD

### Child protection, prevention and reassignment

From 2006 to now CPD implementing project with the support of DFID, Comic Relief and FCDO through Manusher Jonno Foundation. 9000 hazardous child labor is addressed through integrated approach of prevention, rehabilitation, development, protection and sustainability. CPD intends to work with of hazardous situation which are government hazardous list and the vulnerable children who are at risk to be labour. Under the project activities CPD is trying to withdrawn the working children from hazardous works and enrolled them formal/non-formal education. Employers are sensitized towards rights of the working children. For **Reassignment** of the working children, owners follow the code of conduct. CPD is very much involved in workplace improvement using the principles of code of conduct in the working places for children. Through protection, the children are got knowledge on how to acquire skill and empower themselves to keep away from violence, exploitation, torture and discrimination.

### **Early Marriage**

With the support of Save the Children, CPD worked in the project of "SUCHONA" at Sylhet. Under this project 60 trained adolescent provided life skill training to 440 adolescent through peer to peer approach on early marriage, Adolescent Reproductive Health, early pregnancy, nutrition etc. CPD has "Violence Protection Committee" who is responsible to protect any type of violence including early marriage in the community. CPD carried out adolescent led advocacy initiatives in the community i.e. courtyard meeting, day observation, TFD show, photo exhibition, art/debate competition, cultural program etc.

## 4. The organization's involvement in policy formulation and implementation:

## **National Child Labor Elimination Policy (NCLEP)**

CPD has extensive experience with national level advocacy from working with Save the Children and Ministry of Labor and Employment on the National Child Labor Elimination Policy. The policy was finally approved in 2010. CPD as member of TWC participated in series of meetings, workshops in formulation of the policy.

#### **NPA on NCLEP**

The national level advocacy initiatives focusing on implementation of National Plan of Action (NPA) relating National Child labour Eradication Policy 2010 (NCLEP)' through increasing resource allocation, different implementation initiatives taken by government. Representative of TWC is the member of working group.

### **National CSR Policy for Children**

CSR policy focused on children in Bangladesh and building on the experience and the network created previously. On 17th July 2013, the Ministry of Labor and Employment and Save the Children signed a letter of agreement to formulate the National CSR Policy for Children. CPD as implementing organization of CSR project and member of TWC, taking active part in formulation of CSR policy by participating in different national workshop and round table meetings.

#### **National Education**

For the hazardous working children NFE school education program & also govt. syllabus update system, CPD worked in group with other NGOs & Save the Children. The group shared their findings in the meetings, and all collected consulate documents provided to Save the children for sharing in the National Education Policy meeting.

## Child led advocacy on child

Child led organizations are considered as common platforms for children where children's issues are discussed; children's views, ideas and opinions are expressed there. The partnerships with child organizations will promote ownership on the part of the children, youth and PNGOs by ensuring their involvement in joint program monitoring and implementation. A handbook of "Child led Advocacy on child labour" developed by Save the children.

#### **Code of Conduct**

The objective of the code of conduct is to bring the acceptable minimum standard of behavioral pattern among the employers of informal sectors considering the best interest of the children. CPD worked with Save the Children & other group members for incorporating code of conduct in NCLEP. CPD worked on code of conduct as lead organization in introducing Code of Conduct in the informal sector. CPD is very much involved in workplace improvement using the principles of code of conduct in the working places for children.

## 5. The organization's relations with relevant government agencies

## **Dhaka City Corporation including Ward Commissioners**

In the urban areas of Mohammadpur, Hazaribagh, Kamrangirchar and adabor thana maximum people are coming out of Dhaka for job & staying in the slums. Children doesn't have birth certificates, CPD has a good relation with the local ward counselors & secretaries, CPD help peoples for getting birth certificates. PSC students' needs Birth certificate to fill up the DR form, CPD helps them in every necessary step. Local govt. always provide support to CPD to implement the projects of CPD.

## TEO, ATEO

CPD has a good communication with the Thana Education Office & also with the officers. CPDs' NFE primary student always gets free govt. books timely for the relationship with TEO, ATEO and CPD staffs. Also TEO & ATEO suggest NFE teachers about govt. syllabus update.

## **DPE**

Children or students needed primary govt. text books. CPD made good relation with the DPE office & officers, so NFE students are getting the books in time. Also CPD NFE teachers get the update news on DPE & govt. syllabus regularly. DPE staff visited NFE center & gave feedback to make the education more attractive for the working children.

#### **NCTB**

CPD NFE students of junior secondary needed govt. free text books. CPD staffs always make communication with the NCTB office. In the year 2014 EYE program started class vi & vii. District education office doesn't have a single book in their stock. But the help of NCTB staff CPD teachers visited almost all formal school and collect 40% then again NCTB & DEO staffs help to get the rest book. For the relation with these govt. education sectors the children get their books I 20 set books for grade vi to grade vii.

### Bangladesh Bank for children banking

Working children and vulnerable youth can't save their money in any reliable saving systems, as they are under 18 local Banks also can't help them. CPD work with Save the children & some other NGOs in BWCAG for children banking. Now working children can open their account in the local banks under NGO guides' and save their money. Now they are responsive to and getting respect from other people. CPD is a member of BWCAG is always connected with Bangladesh Bank about the update of children banking.

### **Government Primary schools**

Torealise the responsibilities and accountability towards reduction of child labour from hazardous work, Government Primary schools give emphasis to admit the working children and are at risk of becoming child labourers. CPD is strengthened the capacity through training, meeting, workshop of school teachers and school management committee which will help to reach their voice to different levels of decision-making bodies. CPD is provide services to protect school going children from corporal punishment, humiliation etc. in formal school.

#### **BTEB**

CSR project of CPD started working with BTEB from last year 2013. CPD has got a big professional training unit which provides various training to vulnerable adults on the market relevant useful trade. Chairman BTEB visited CPD CSR. Chairman also visit a CPD-CSR job fair for the trained adults and he advised CPD to apply for registration from BTEB as CPD have market relevant trainings on TVET. CPD has applied for it & soon it will get the registration from BTEB.

#### **DC** office

Dhaka DC office has a regular relation with NGOs. CPD staff attends the regular meeting with DC office for sharing projects update new, also we submit a monthly report there. CPD have yearly DC certificate for the running projects. In the regular monthly meeting in DC office CPD & other NGOs have decided to go in a portal web page where all can share their programs in Dhaka city.

## **NGOAB**

CPD has good relationship with NGOAB. As a voluntary organization CPD have registration of NGOAB. For the project connecting with the govt. relevant dept. NGOAB helps CPD on project approval and project fund transfer.

## 6. The organization's involvement in networking

#### **ATSEC**

ATSEC stands for Action against Trafficking in Sexual Exploitation of Children. This forum consists of the organization who are involved in the anti-trafficking program. It has got a chapter in Bangladesh, India, Nepal and Pakistan. As CPD work in this issue became the member of ATSEC. ATSEC provides technical support to the member in addressing the issue of human trafficking in general. ATSEC has been working in anti-trafficking issue from its inception.

#### **TWC**

TWC is an informal civil society network comprising of national organizations working on establishing child laborers' rights as well as empowering them socially, politically and economically. It is also a

partnership-based network where numbers of organizations are involved in dealing with child and youth laborers' issues. It consists of the partners who are working in establishing child rights with financial and technical support of Save the children. CPD is one these partners. CPD's has active role in formulating and getting approved of NCLEP, implementing code of conduct for the employers, NPA. Now it working in formulating CSR policy.

#### **BSAF**

BSAF has been established in establishing the rights of the children for last 23 years. Main objective is to do the advocacy on the children issue. CPD as an active member of BSAF participated in different meetings, workshops, seminars on violence against children. It is a information bank, it collects and preserves all the information's of child rights violations.

#### **CUP**

CUP is a networking forum NGOs working in urban slums. CPD is member of CUP. CPD has made a coordination body with CUP to meet the problems arise in the slums such as slum eviction, emergency response. For the urban poor CUP have relevant program for their safety, CPD always participate on those responses.

#### **DAWN Forum**

This forum is a collective entity to raise the voice of the adolescents. Protest against violence, early marriage, dowry and other relevant issues. Advocacy with GO, NGO and civil society on need for focusing on adolescents, particularly girls and other specific disadvantaged groups such as street and working adolescents, disabled and young sex workers, problems of low wages for working adolescents, add AFLE into national curriculum, include gender equality and gender equity into national curriculum, motivate government to provide stipend for the urban girls and boys.

#### **MFSCR**

Movement for Street child Rights (MFSCR) network. The object of this network is to play advocacy role for incorporate street children rights in child law, CPD is a member of this network. CPD staff participate in different rally, workshop, meetings organized by this forum.

#### **CRGA**

Work on Child Rights Governance (CRG) aims to build a society that fulfils children rights and achieving this will benefit millions of children with long-lasting results. It is an effective strategy for impacting on children's lives at scale, resulting in structural and therefore lasting change. There are two essential components to good CRG – firstly, a government that takes real responsibility for implementing children's rights and secondly, a mobilized civil society, including children, which stands up for those rights and holds the governments and other relevant stakeholders like the corporate sector accountable. Responsive government performance, transparency of information and decision-making and robust accountability mechanisms are essential for the realization of children's rights. Parallel to this, an active and well-organized civil society in support of children's rights is an important counterpart to governmental actions. CSOs can hold their governments to account, advocate with and for children, and influence public attitudes. This includes that also the governance structures within the CSOs, including child- and youth-led organizations are more child responsive and taken children's issues into account.
